NOTICE OF WILLINGNESS
Prince William Parkway Sidewalk Project

The Prince William County Department of Transportation (PWC DOT), in cooperation with the Virginia Department of Transportation (VDOT) and the Federal Highway Administration (FHWA), proposes the construction of approximately 2,300 linear feet of 5-foot-wide sidewalk with a proposed 4-foot-wide grass buffer. This project will construct a missing segment of pedestrian facility so pedestrians can continuously walk on the north side of Prince William Parkway from Homer Road Commuter Lot Entrance to 650' West of Summerland Drive (A separate project will be responsible for the final connection to Summerland Drive). Other improvements, such as upgrading connecting curb ramps are also part of this project. Prince William Parkway (Route 294) is classified as an Urban Principal Arterial GS-5 with a 50 mile per hour design speed. The project is state/federally funded, through the specialized state/federal MAP21/CMAQ and MAP21/RSTP funding and to be constructed via the VDOT LAP Process. The sidewalk construction will not require dedication of right-of-way and easements.

In accordance with the National Environmental Policy Act (NEPA) and 23 CFR 771, a Programmatic Categorical Exclusion (PCE) has been prepared under an agreement between VDOT and FHWA for the project. The project will not impact resources protected by Section 4(f) of the Department of Transportation Act or Section 106 of the National Historic Preservation Act.

The Department of Motor Vehicles (DMV), under the Code of Virginia 46.2-1572(4) and 46.2-1573, is conducting a formal evidentiary hearing at the request of Rivian Automotive, LLC (Rivian), a Commonwealth-licensed manufacturer of electric vehicles.
